He was named the Vice President in 2010. Marc has over twenty years of experience in international trade and economics.

Prior to joining the Council, Marc spent four years in the U.S. Congress. From 1999-2001 he was a member of the Professional Staff of the House International Relations Committee. From 2001 to 2003, he served as the international economic and foreign policy advisor to Congressmen Gregory Meeks of New York, a member of the House Foreign Affairs and Financial Services Committees.

Matt Ingeneri has served since July 2022 as the Deputy Director of Economic Policy in the State Department's Bureau of East Asia and Pacific Affairs: supporting the first U.S. host year of the Asia Pacific Economic Cooperation (APEC) forum since 2011, coordinating the Department's support of Indo-Pacific Economic Framework (IPEF) negotiations, organizing the Indo-Pacific Business Forum (IPBF), and expanding economic engagement through the Quad. Before returning to Washington, Matt was the Economic Strategy Unit Chief at the U.S. Embassy in New Delhi, responsible for leading Mission India's implementation of the Indo-Pacific Strategy as well as bilateral investment, macroeconomic, and aviation issues. Matt previously worked on trade and investment issues in Southeast Asia for over 10 years, serving as Deputy Economic Counselor at the U.S. Embassy in Kuala Lumpur, Director for Singapore, Vietnam, and ASEAN at the Office of the U.S. Trade Representative, and Senior Asia Trade Officer and Philippines Desk Officer at the State Department. Before joining the State Department, Matt was an attorney at the D.C. firm Howrey & Simon, specializing in foreign anti-trust reviews of mergers and acquisitions and intellectual property litigation. He received his BA from Sarah Lawrence College and his JD and an MA in International Relations from Boston University, and is a member of the New York and Washington, D.C. bars.









Ernie Bower is recognized as one of the world's leading experts on the Asia Pacific. Brian Harding joined the U.S. Institute of Peace in May 2020 as a senior expert and has led a major expansion of USIP's programming in Southeast Asia and the Pacific Islands, including the launch of new country programs in Vietnam, the Philippines and Papua New Guinea. He comes to USIP with more than 15 years of experience in Southeast Asian affairs in government, think tanks and the private sector.

In the private sector, Harding has advised many of the world's most prominent companies and financial institutions on political risk and leadership dynamics in Southeast Asia. Harding holds degrees from Middlebury College and The George Washington University and has studied at universities in Yogyakarta, Indonesia and Kyoto, Japan. In Southeast Asia, he has also been a Fulbright research fellow in Indonesia and taught English in Nong Khai, Thailand.

FORMER U.S. AMBASSADOR TO MYANMAR

Ambassador Mitchel was most recently President of the National Democratic Institute from 2018 to 2023. From 2012-2016, he served as U.S. Ambassador to the Republic of the Union of Myanmar (Burma), where he was America's first ambassador to the country in 22 years. From 2011-12, he served as the U.S. Department of State's first Special Representative and Policy Coordinator for Burma, with the rank of ambassador. After leaving office was

Mitchell served as Principal Deputy Assistant Secretary of Defense, Asian and Pacific Security Affairs (APSA), in the Office of the Secretary of Defense. He spent six months as acting APSA Assistant Secretary of Defense and was responsible for overseeing the Defense Department's security policy in Northeast, Southeast, South, and Central Asia. Most recently, Mitchell has been a senior advisor at the Albright Stonebridge Group, the United States Institute of Peace, and the Center for Strategic and International Studies, as well as a lecturer for the Stanford-in-Washington program.

Rena Sasaki is a Ph.D. student at Johns Hopkins SAIS and a fellow of the Pacific Forum's Next Generation Young Leaders Program.

Sasaki was a senior associate at the global management consulting firm Strategy& and has more than five years of experience engaging in defense and security projects with Japan's Ministry of Defense and its Acquisition, Technology, and Logistics Agency and the general defense industry. She previously served in Kathmandu, Istanbul, Tashkent, and The Hague, in addition to Washington assignments in the European and Economic Bureaus, as well as the Bureau of Oceans and International Environmental and Scientific Affairs. Lindsey W. Ford is the Deputy Assistant Secretary of Defense for South and Southeast Asia. In this role, she serves as the principal advisor to senior leadership within the Department of Defense for all policy matters pertaining to development and implementation of defense strategies and plans for the region. Ambassador Lui then served as the Minister for Transport from 2011 to 2015 and concurrently Second Minister for Foreign Affairs from 2011 to 2012 and Second Minister for Defense in 2015.

Before Parliament, Ambassador Lui was a Singapore Armed Forces (Overseas) scholar and served in the Republic of Singapore Navy (RSN), rising to the position of Chief of Navy in 1999. He was appointed Chief Executive of the Maritime and Port Authority of Singapore in 2003 and concurrently Deputy Secretary (Land), Ministry of Transport. By 2005, the Ambassador joined the Housing and Development Board (HDB) as Chief Executive Officer.

Ambassador Lui graduated with a Bachelor of Arts from the University of Cambridge, Trinity College United Kingdom in 1983. He obtained a Master of Arts Degree in International Relations from Tufts University, USA in 1994.

Because of his achievements and service, Ambassador Lui was awarded the Public Administration Medal (Bronze) (Military) in 1993, the Public Administration Medal (Gold) (Military) in 2000, and the Long Service Medal in 2005.

Ambassador Lui is married to Madam Teng Soo Fen and they have two children. He enjoys traveling, reading, cricket, baseball, and American football.









AMBASSADOR PIPER CAMPBELL

AMBASSADOR OF THE REPUBLIC OF SINGAPORE TO THE UNITED STATES OF AMERICA

Chair of the Department of Foreign Policy and Global Security (FPGS), Ambassador Piper Campbell began teaching at AU in January 2020. She was Administrative Director of SIS's Foreign Policy (USFP) and Global Governance (GGPS) graduate programs before becoming inaugural chair of FPGS. This followed a distinguished, 30-year diplomatic career. Campbell also has taught national security strategy at the National Defense University's National War College.

Piper Campbell retired from the State Department in April 2019, with the rank of Minister Counselor.
